This face shield complies with the requirements of the European Directive 89/686/EEC annex II by means of European Standards EN166:1995/EN166:2001 or EN1731:1996/EN1731:2006, "Personal Eye Protectors-Specification"

STORAGE

When not in use, it is recommended to store the face shield in a clean and dry poly bag or case for visor protection.

DIRECTION FOR USE

This face shield has been designed for your personal safety. It must be worn for the whole duration of exposure to hazards. Leave the work area if dizziness or irritation occurs, or if the face shield becomes damaged.

CLEANING AND MAINTENANCE

To maintain your face shield in good condition:

- 1. Do not use abrasive materials, clean and rinse in warm soapy water and dry with a soft cloth.
- 2. Any part of face shield which are in contact with the wearer shall be disinfected by alcohol

FIELD OF USE

This face shield is designed to protect the user against eye and face injuries through mechanical impact or liquid splashes. (Except VM81MV/M855/VM85M visor). The face shield is marked on the brow protection and visor with a series of numbers and symbols to indicate the manufacturer, the field of use, the protection capabilities and performance characteristics of the face shield. Appropriate markings on ocular and frame are signified as follows:





REPLACEMENT OF SPARE PARTS, ACCESSORIES AND INSTRUCTIONS FOR FITTING.

Only use original spare parts. To replace the visor, you should ensure the compatibility of marking and that the right visor is fitted. DURATION OF USE

Inspect for damage regularly. When the face shield has become brittle, replace it. If parts of face shield or face shield itself must be replaced, please use recycled material which is written on product.

WARNING

- 1. This product is for free protection against moderate impact hazards but NOT unbreakable.
- 2. Do not modify or alter the face shield.
- 3. Pitted or scratched screen reduce vision and seriously reduce protection and should be immediately replaced.
- 4. This face shield does not have filtering. It does not protect against molten metal splash, hot solids or electrical hazard. Mesh visor (VM81M/VM855/VM85M) does not protect to liquid projection and UV and IR light.
- Always check with supervisory personnel to ensure you are being given the proper protection relative to working conditions, consult relative European Standards.
- 6. The materials which may come into contact with the wearer's skin could cause allergic reactions to susceptible individuals.
- 7. If the symbols S, F, B and A are not common to both ocular and the frame then it is the lower level which shall be as signed to the complete eye-protector.
- 8. Mesh screens and face shield with S marking should not be used when a foreseeable risk of hard and sharp volatile particle is present.
- 9. The protectors against high speed particles launched on ophthalmic spectacles can cause shock, causing a hazard to the user.
- 10. If protection against particles launched at high speed to extreme temperatures is required, the protector must be marked with the letter T immediately following the letter of impact, ie, FT, BT or At. If the letter of impact is not followed by the letter T, the face shield must be used only against particles launched at high speed at room temperature.
