BASIC INFORMATION

DESCRIPTION

This is a 2-element front kit consisting of 1 Schuko socket, 1 key and 1 USB charger. The mechanism has a glossy white finish and is suitable for vertical and horizontal installation. Simon recommends that it be used in bedrooms and stands out for offering USB connector, plug and light switch that can be by push button.

It has a mixed system of emborning, by cutt and screw, for the plug and USB respectively. The manufacturer recommends exposure to a temperature between 5 and 40°. In the case of the recommended storage temperature range it ranges from -25 to 50 ° C. For cleaning a cloth dampened with soapy water is required, avoiding products containing chlorine.
