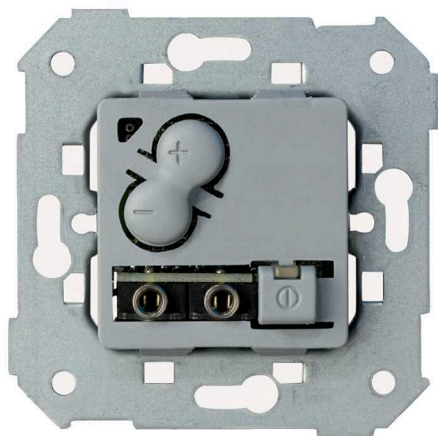


Digital control with Walkman input and headphone output for sound centre with 1 trunking

Other observations: Type of FM tuning and bandwidth 87.5 to 108 Mhz. Power of output: 40 VA. The wire that are supported is 0.25 to 0.75 mm (wire stripping of 7 mm).
