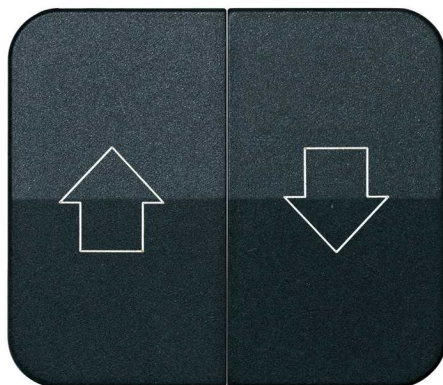


Double rocker for blinds mechanism with security latching graphite Simon 75

BASIC INFORMATION

DESCRIPTION

Double rocker, finished in graphite colour, for roller shutter mechanisms (includes engravings for raising and lowering of the same) without latching of security, of the Simon 75 series. This rocker to be installed both in surface-mounted and recessed, so it in places with a temperature located between 5 and 40°C, although it can withstand extreme temperatures of -25 to 50°C, approximately. Its design is the regulation UNE-EN 60669-1: 2002 + A1: 2003 + A2: 2009 and is made of thermoset plastic, a material that is very easy to clean: just wipe it with a soft, damp cloth, moistened in soapy water, not reach having to use abrasive cloths or cleaners with chlorine. The Simon 75 series is composed of rockers (in 6 different colours), parts pieces (in 15 colours), mechanisms and frames in 13 finishes (), which offer infinite combinations of colours. In addition, it is a series compatible with the Simon 77 mechanisms, so that it does not need to strip or braid the cables or use additional tools to place them.
