BASIC INFORMATION

DESCRIPTION

Front kit to occupy 1 element that has 1 shutter switch with Simon iO system. This device is made in beautiful black colour and matte finish. It is part of the Simon 100 series and is compatible with the rest of the products of the 100 series.

This device occupies 1 element and has a nice matte black finish, and can be installed in any available space. It is a standard product, which can be marketed throughout the EC, and its dimensions are 85.5x83.5mm.

The content that comes with its packaging will be the mechanism and instructions that could be very useful in case of any doubt regarding its installation.

Its type of activation is by push-button. Its emborning is screw-based and its voltage capacity is 250V.

It is a device that can be installed in a universal box. It can be installed both vertically and horizontally.

To ensure good maintenance it must be installed in a place with an operating temperature range of 5° C to 40° C and a temperature range for storage of -25° C and 50° C.

For cleaning it is recommended to use a soft cloth with soapy water, thus avoiding abrasive cleaners.
