DESCRIPTION

Front kit designed to occupy two elements with a Schuko plug base, a key and a USB charger with gloss black finish and that you can find in the Simon 100 series. The intensities with which the kit works are as follows: the USB port requires an intensity of 2.1 A and for the Schuko a 16 A plug. It also needs a power of 230 V ~.

For installation you need to know that the USB is screwed and the Schuko plug is cut so you can install it using the one-click option. The operation of the kit is by the push-toggle and insert system.
