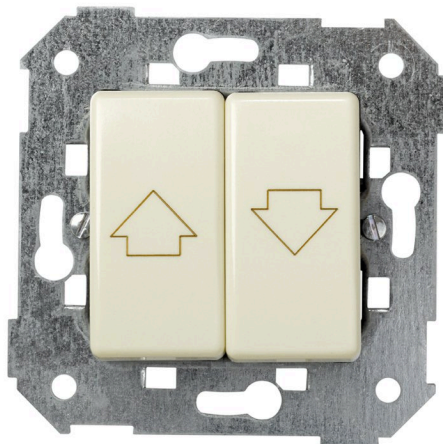


Set of 2 push-button switches for blinds 10A 250V~ without latching and with fast terminal connection ivory Simon 27 Play

A good example of this is the group of 2 push buttons for blinds without latching and with quick terminal connection in ivory colour included in this range, measuring 45x45, this system has a current of 10 AX and a voltage of 250V ~, a cable section of 1.5 to 2.5 mm and stripping of 11 mm wire Another of its advantages is its great resistance to knocks and scratches. This quality is obtained thanks to the metal components with halogen-free insulation and thermoplastic trim with which it has been manufactured. This is a mechanism that requires control device. It includes a blinds up/down symbol and is compatible with the frame in the Simon 27 series, 27 Play, 27 Neos, 27 Scudo, 27 Centralizations and 44 Aqua.
