DESCRIPTION

Front kit for 1 element with 1 matte white Simon iO blind switch Simon 100. It is a product of the Simon series 100 whose type of operation is by push-button.

Its type of emborning is screw-based and is installable in a universal box, both vertically and prominently. The voltage capacity of this kit is 250V.

The interval for the temperature of its correct operation will be from 5° C to 40° C and this must have a temperature range for its storage from -25° C and 50° C. For optimum maintenance, it is recommended to dampen a soft cloth slightly in soapy water.

It occupies 1 element, is a standard product and has a size of 85.5x83.5mm. The content that comes with its packaging is the mechanism and instructions so that the user can consult them for any doubts.
