BASIC INFORMATION

DESCRIPTION

Front kit for 1 element with master key Simon iO designed to operate blinds made in beautiful white and matte finish, part of the Simon 100 series and compatible with the rest of the mechanisms of that series.

The content of its packaging includes the mechanism and instructions. This kit has dimensions of 85.5x83.5mm and a voltage of 250V. It has no claw. The type of activation is via push button-rocker.

It is a standard product that can be marketed throughout the EC. It can be installed both vertically and horizontally. The type of emborning is screw-based.

Thanks to its beautiful white colour and matte finish it can be installed in any space that is available, adding a fresh touch to the environment.

For proper maintenance and good cleaning, it must be installed in an area where there is an operating temperature range that varies between 5° C and 40° C and the temperature range for storage ranges from -25° C and 50° C.

For cleaning, simply use a soft cloth slightly dampened in soapy water, without using chlorine cleaners.
