### 4.1. Description of first aid measures

### 5.1. Extinguishing media

### 5.3. Advice for firefighters

## 6.2. Environmental precautions

## 6.3. Methods and material for containment and cleaning up

**Methods for cleaning up** Clear up spills immediately and dispose of waste safely. Eliminate all ignition sources if safe to do so. No smoking, sparks, flames or other sources of ignition near spillage. Under normal conditions of handling and storage, spillages from aerosol containers are unlikely. If aerosol cans are ruptured, care should be taken due to the rapid escape of the pressurised contents and propellant. Provide adequate ventilation. Small Spillages: Wipe up with an absorbent cloth and dispose of waste safely. Large Spillages: If the product is soluble in water, dilute the spillage with water and mop it up. ### 7.1. Precautions for safe handling

**Usage precautions** Read and follow manufacturer's recommendations. Wear protective clothing as described in Section 8 of this safety data sheet. The product is flammable. Avoid exposing aerosol containers to high temperatures or direct sunlight. Keep away from heat, hot surfaces, sparks, open flames and other ignition sources. No smoking. Do not spray on an open flame or other ignition source. Do not pierce or burn, even after use. Spray will evaporate and cool rapidly and may cause frostbite or cold burns if in contact with skin. Do not expose to temperatures exceeding 50°C/122°F. Avoid inhalation of vapours and spray/mists. Avoid contact with eyes.
